Appointments must be made with the elections team to submit nomination papers.

They must be delivered to the following address and not the Gateway.

Elections Office, Room 108, Town Hall, Tunbridge Wells Borough Council, Kent, TN1 1RS.

The following papers must be delivered together and by hand (this includes courier delivery):

- 1a: Nomination Paper
- 1b: Home address form
- 1c: Candidate's consent to nomination

You will obtain a receipt from one of the members of the Election Office when delivering your Nomination Papers to the Town Hall.

The following papers can be delivered **by hand or by post**. If you do decide to post we advise you to return these by recorded delivery:

- 2: Certificate of authorisation must be original document
- 3: Request for a party emblem
- 4: Notification of election agent

Ensure that where signatures are required, you submit the **original signed version** of each completed paper. Documents without original signatures cannot be accepted. If a nomination paper is valid we will send you a Certificate of Valid Nomination as soon as possible after checking.

You are strongly advised to submit your Nomination Paper a couple of days before the deadline just in case there are any problems which require you to re-submit the paper. Late submission may result in insufficient time to rectify any problems. Please complete the contact details form enclosed within this pack so we can contact you as quickly as possible if there is problem with your Nomination Paper.
