· Contact with Capel NP group.

A provisional meeting with Capel NP group and their consultants has been arranged for Tuesday 22 February (early evening) to discuss design codes.

 Jon Herbert (Troy Planning) has been informed about the meeting held between the sports groups and Greg Clarke. He has recommended that the results of the consultation be considered before any further discussion/decisions about the proposed location of a sports hub take place.

Although permission had been given to display the consultation documents in the library, this will not now be possible as the library will be closing on the 10<sup>th</sup> March for refurbishment.

### 3. Neighbourhood Plan Regulation 14

An 8 week consultation is to be held from 28th February to 25th April.

Members review the publicity material for the consultation and amended the following:

Leaflet – Paddock Wood Should be on one line, add the wording "inform developers" in the second paragraph. Subject to the amendments the leaflet was approved. The print run was increased to 4,000.

Questionnaire – boxes to be made smaller. Check whether they could expand as they are filled out online.

4 banners had been ordered and would be installed around the town

SL would ask the community volunteers to help with the leaflet distribution

TWBC have advised that a Strategic Environmental Assessment (SEA screening) is not required.

# 4. Any Other Information

JT updated the group on Heritage PW. The group had formed in 2017 and was looking to save the Wesley Centre. They wish to preserve the building and the grounds. The group are currently working on a business plan and will be sending out a questionnaire to all residents on the future of the building. They have also been in contact with staff at the Amelia Scott in TW and connecting with other parishes in the areas.
