CCB195 PROJECT UPDATE

Update on contract/works

- Meter install 21st Feb
- Practical completion 3rd March (handover of building)
- Operations manuals 98% completed, will be finished 3rd March FM contracts and Collateral Warranties are with Carol Williams for checking/signing Health and Safety file 98% done
- Snagging almost completed
- > Gradient on tennis court being investigated by JW with Baxalls
- > Tree being monitored is still fine and continues to be monitored
- Electricity bill has been forwarded to Baxalls for confirmation
- > Sibley Pares have had interest from possible hirers and is showing them round
- Football pitches comments from Carl received on location being moved and drainage plus fencing work (JW investigate S106 money being allocated to the works specifically for football pitches)
- Security fencing to stay in place to end of April to protect the grass seed

Action:

Carl to map where the fencing needs to be added as well as the costs for the pitch work. Pass to **JW**.
